**From your Legislative Advocate:**

The 2010 election cycle has been a strange one indeed... one with a lot of surprises and unexpected outcomes. The emergence of a third party (Tea Party) changed a lot of races. In the end, Florida's government is one that is dominated more by one party than at any time in the past forty years. The Republicans now hold every cabinet office and have an extraordinary majority in both houses of the legislature.

The make-up of the legislature and announced agenda of the governor will have significant impact on the delivery of children's services, especially Medicaid. On the very first day of the organizational session, the legislature took up a discussion on Medicaid revamping and indicated that it will be a major focus of the regular session this coming spring. FAPD will be actively involved in those discussions to push for increases in provider fees and expanded coverage for children.

Meanwhile, the federal trial of the litigation FAPD filed against the state continues in Miami and our attorneys remain optimistically confident that the court will see the merits of our case and rule accordingly.

Between the courts, the legislature and the federal government we see 2011 as a busy year for FAPD legislative involvement and I continue to honor the opportunity to represent FAPD and more importantly the dental needs of Florida's children, both those who can pay and those who cannot.

Our legislative efforts in Florida have caught the attention of the American Academy of Pediatric Dentistry and other state organizations around the county. We have become a model for others to follow and I am honored to have been asked to address the AAPD annual meeting next spring in New York to tell others what we are doing in Florida.
