**From your Legislative Advocate:**

The 2009 regular session of the Florida Legislature has concluded and a reduced budget has been adopted. Even with the infusion of federal stimulus funds, there is insufficient income to cover government spending at previous levels, thus resulting in massive cuts.

But, there were some bright spots. Both chambers of the Florida Legislature unanimously passed Senate Bill 918 which will remove barriers to help children get and keep KidCare coverage. This important legislation will now go to the Governor.

A huge infusion of federal cash due to the stimulus package has resulted in an overall increase in health care spending in this year's budget and

kept intact some high profile health care programs that were set to expire. Nearly \$3 billion in additional federal money - most of it coming due to an increased federal Medicaid matching rate - was pumped into health care and human services programs. Additionally, state lawmakers agreed to collect nearly \$1 billion from increasing the taxes on cigarettes by about \$1 a pack.

The state's Medicaid program will grow from roughly \$16 billion overall to just under \$18 billion and there will be enough money to pay for the increasing Medicaid caseload. Florida will be serving an estimated 2.5 million people in the Medicaid program in the coming year. However, while additional funds were allocated for increased recipients, provider fees were not.

This is the third legislative session since we filed the litigation against the state and so far both the legislative and executive branches have been rather oblivious to it. The discovery process has been arduous and so far, we have taken more than 125 depositions and examined over a million separate items of evidence.

The case is set for trial in Miami this coming August. On May 12, a mediation session was held in Miami. I appeared on behalf of FAPD and we spent nearly eight hours trying to resolve primarily the non monetary issues of the litigation and made some progress. Our evidence is compelling.

Since the filing of our litigation three years ago, the problem in Florida has only gotten worse and now our state ranks dead last in the nation in the percentage of eligible children who receive Medicaid dental care and while dental utilization rates for Medicaid children is increasing nationally, it is falling in Florida, and dentist participation will continue to decline if the reimbursement remains under provider costs. Though children comprise more than half of Florida's Medicaid enrollees, expenditure on children comprise less than a fifth of the Medicaid budget. We are optimistic as we prepare for trial.

Thank you all for the honor of being your legislative voice in Tallahassee.
